- *Information automatically collected*

in Short: Some information – such as your Internet Protocol (IP) address and/or browser and device characteristics – is collected automatically when you visit our Services. We automatically collect certain information when you visit, use, or navigate the Services. This information does not reveal your specific identity (like your name or contact information) but may include device and usage information: such as your IP address, browser and device characteristics, operating system, language preferences, referring URLs, device name, country, location, information about how and when you use our Services: and other technical information. 3. WHAT LEGAL BASES DO WE RELY ON TO PROCESS YOUR INFORMATION?

5. DO WE USE COOKIES AND OTHER TRACKING TECHNOLOGIES?

- *Right to Limit Use and Disclosure of Sensitive Personal Information*

We do not process consumer's sensitive personal information.

- *Verification process*
